Serving the residents of Bournville, Cotteridge and Stirchley



As part of our negotiations with ASDA and TESCO your local Councillors, with the support of the city council, are proposing the setting up of the Stirchley Village Regeneration Board.

Its board will comprise your 3 local city councillors, council officers and local residents and traders.

The purpose of the Stirchley Village Regeneration Board will be to oversee and manage the revival of the Stirchley High Street as a shopping centre over the next 10 years.

It will do this by actively marketing Stirchley Village as a destination for new retail businesses. At the same time it will ensure that the Stirchley High Street has the type of retail units that new business require and will ensure that, through a range of improvements, the Stirchley High Street becomes an dynamic environment that attracts both new businesses and new shoppers.

For the first time ever improvements will be achieved through a mechanism of part funding improvements to retail premises such as new retail frontages, repairs to existing shops and the maintenance of a well managed high street.

For the first time ever, each year it will be set targets to attract new retail businesses to Stirchley and to ensure that the retail properties are maintained to a high standard.

All of these improvements will be funded from grants and monies extracted from the Supermarkets.

Exciting new play equipment for Hazelwell Park

New Fast food takeaways will not be allowed in Stirchley

Your three councillors are the only people to have consistently objected to very single fast food takeaway over the last 12 years that have applied to come to Stirchley. We have not always been successful but we have opposed them because we know Stirchley has far too many and they blight the shopping centre.

Councillor Nigel Dawkins said, "Christmas came again to Cotteridge and Stirchley and your local councillors were honoured to have help".




Bournville, Cotteridge and Stirchley have, once again, been confirmed as the cleanest suburb in Birmingham!


Midlands Co-operative retail chain, accused of blocking the multi million pound regeneration of Stirchley.

Cllr Nigel Dawkins has called upon the giant Midlands Co-operative retail chain, to stop blocking the multi million pound regeneration of Stirchley.

The Midlands Co-operative chain, owners of the Co-op Superstore based in Stirchley, has for many years done all that they can, using a variety of legal methods, to block a TESCO supermarket from coming to Stirchley.

The result is that over the last 10 years the northern half of Stirchley has been blighted and has continued to decline until

Survey shows that there is overwhelming support for TESCO and ASDA

Your local councillors, last summer, conducted an extensive survey of every household in Stirchley to ask their views on whether TESCO and ASDA should be allowed to come to Stirchley.

Over 2,000 households were invited to reply.

We had over a 1,000 responses back and the overwhelming opinion of Stirchley residents was that these two supermarkets should be allowed to come to Stirchley. Amongst the views expressed were;

- 1. They would help to regenerate Stirchley,
- 2. They would encourage competition and drive down prices,
- 3. They would bring much needed jobs to Stirchley,
- 4. The CO-OP has had a monopoly for too long and is expensive,
- 5. We would need to sort out the traffic before they came,
- 6. They would bring new retail businesses back to Stirchley,
- 7. They would supply much needed car parking.
